INDIVIDUAL STATE FOREST or PRIVATE PROPERTY (**No pursuing or taking of birds, No use of live ammunition**)

1. Except: No training of hunting dogs afield April 16 through July 14 on State Forest land (to protect ground nesting.)
2. No training is allowed, on other DNR Administered Lands (WMA's, AMA's, SNA's, State Parks, Rec Areas or on WIA)
3. Permittee may only carry a firearm with blank cartridges and shells when the season is not open for any game bird.
4. Permit does not supersede local ordinances or zoning laws (Ex. Discharging firearms, allowing dog(s) to run off lead.)
5. This permit is not valid without a Special Use Permit from the Area Forestry Office. Find your local Area office using [Office Locator](#).

INDIVIDUAL STATE FOREST or PRIVATE PROPERTY (Taking of domesticated/game farm birds using live ammunition)

1. Except: No training of hunting dogs afield April 16 through July 14 on State Forest land (to protect ground nesting.)
2. No training is allowed, on other DNR Administered Lands (WMA's, AMA's, SNA's, State Parks, Rec Areas or on WIA)
3. Permittee may use live ammunition on domesticated birds or banded game birds from game farms.
4. Domesticated birds, other than pigeons, and game farm birds must be marked in a manner that makes them visually identifiable prior to being taken (marking with dye, or with a streamer attached to the leg). A band alone does not constitute sufficient visual identification of game farm birds.
5. Permit does not allow the pursuing or taking of wild birds.
6. This permit is not valid without a Special Use Permit from the Area Forestry Office. Find your local Area office using [Office Locator](#).

ORGANIZATION FIELD TRIAL on STATE FOREST or PRIVATE PROPERTY (Taking of domesticated/game farm birds using live ammunition)

1. **May only be issued to an organization.**
2. No training of hunting dogs afield April 16 through July 14 on State Forest land (to protect ground nesting.)
3. Domesticated birds, other than pigeons, and game farm birds must be marked in a manner that makes them visually identifiable prior to being taken, by either marking with dye, or with a streamer attached to the leg. A band alone does not constitute sufficient visual identification of game farm birds.
4. Permit does not supersede local ordinances or zoning laws (Ex. Discharging firearms, allowing dog(s) to run off lead.)
5. Permit does not allow the pursuing or taking of wild birds and the commissioner may limit the dates approved.
6. This permit is not valid without a Special Use Permit from the Area Forestry Office. Find your local Area office using [Office Locator](#).
7. Organizational Field Trials **must be listed on the next page**; and are valid only for the property described.

*Permittees must prevent the introduction, establishment and spread of invasive species during activities on public waters and DNR-administered lands. This applies to all activities performed on all lands under this permit and is not limited to lands under DNR control or public waters.

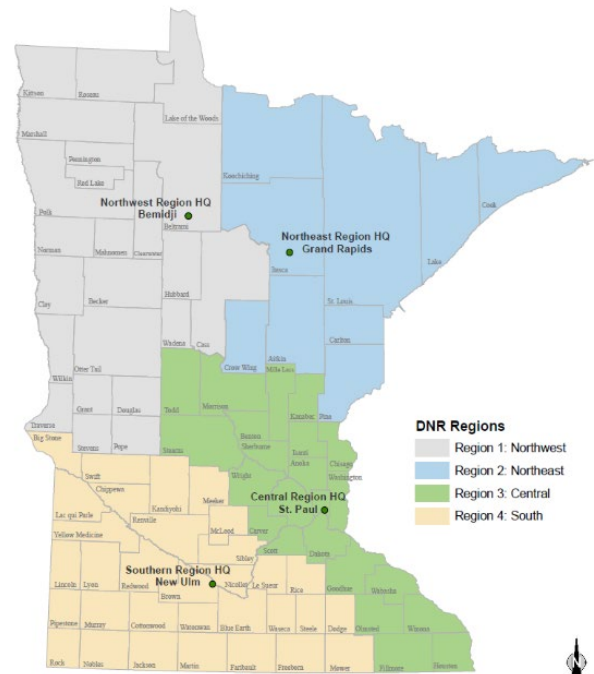
